FEE PAYMENT POLICY

1. Annual Membership Fee of KES.12,000 will be paid at the point of joining and runs for the season, i.e. August to July
2. Coaching Fees will be invoiced on a Quarterly Basis with August as a Season start .
 - I. Quarter 1 – August, September, October.
 - II. Quarter 2 – November, December, January.
 - III. Quarter 3 – February, March, April.
 - IV. Quarter 4 – May, June, July.
3. All fees will be invoiced by the 20th of day of the last Month of the previous Quarter.
4. All fees are payable by the 1st day of the Month or Quarter, depending on whether the payment option is Quarterly or Monthly. Should a parent opt to leave or take a break (for anything other than a Medical reason) in the course of the Quarter, they shall still be liable for the fees for the Quarter, unless ONE Quarters Notice has been given.
5. If payments are not received by the 5th day of the Month or Quarter, the swimmer(s) will be **EXCUSED** from swimming without further notification from the Club.
6. Swimmers changing Squads during the Quarter, if they pay on a Monthly basis will immediately begin paying the higher amount for which a revised Invoice will be raised. Those paying on a Quarterly basis will begin payment of the new rate at the start of the next Quarter. i.e. a swimmer who pays Quarterly Fees and moves Squads on 1st September, will only pay the new rate of the new Squad in November, whereas one who pays on a Monthly basis will pay the new rate for the month of September if they move Squads on 1st September.
7. Please Note, Coaching Fees are based on the Quarter and not on available or swum sessions. Consideration has already been given to the breaks in the different Quarters to even out payments.
8. There are **NO PAYMENT BREAKS** . A break will only be accepted after 1 Quarter's Notice or 1 Quarter Fees paid in lieu of Notice. At this point Membership is suspended.
9. If payment is not received, it will be deemed that the member has RESIGNED and they will have to RE-APPLY to join the club, with Annual Membership Fees becoming applicable.
10. Fees will also cover internally run camps in Nairobi at our St.Christophers, excluding accommodation, or a different venue etc. if it is a residential camp.
